Dear Participants and Alternate Payees:

This is a summary of the Annual Report of the CONSTRUCTION INDUSTRY RETIREMENT FUND OF ROCKFORD, ILLINOIS, EIN 36-6131610, Plan No. 001, for the period of November 1, 2022 to October 31, 2023. The Annual Report has been filed with the Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BASIC FINANCIAL STATEMENT

Benefits under the Plan are provided by a trust. Total Plan Expenses were \$36,480,537. These expenses included \$1,044,717 in administrative expenses and \$35,435,820 in benefits paid to Participants and Beneficiaries. A total of 11,267 persons were Participants in or Beneficiaries of the Plan at the end of the Plan Year, although not all of these persons earned the right to receive benefits.

The value of Plan Assets, after subtracting Liabilities of the Plan, was \$473,836,511 as of October 31, 2023, compared to \$450,417,550 as of November 1, 2022. During the Plan Year, the Plan experienced an increase in its Net Assets of \$23,418,961. This increase included unrealized appreciation in the value of Plan Assets; that is, the difference between the value of the Plan's Assets at the end of the year and the value of the Assets at the beginning of the year or the cost of the Assets acquired during the year. The Plan had total income of \$59,899,498, including (but not limited to) employer contributions of \$29,659,798, other contributions of \$171,956, realized gains of \$81,797 from the sales of assets, earnings from investments of \$29,829,414 and other income of \$156,533.
