Dear Participants and Alternate Payees:

This is a summary of the Annual Report of the CONSTRUCTION INDUSTRY RETIREMENT FUND OF ROCKFORD, ILLINOIS, EIN 36-6131610, Plan No. 001, for the period of November 1, 2021 to October 31, 2022. The Annual Report has been filed with the Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BASIC FINANCIAL STATEMENT

Benefits under the Plan are provided by a trust. Total Plan Expenses were \$29,759,940. These expenses included \$1,042,014 in administrative expenses and \$28,717,926 in benefits paid to Participants and Beneficiaries. A total of 11,049 persons were Participants in or Beneficiaries of the Plan at the end of the Plan Year, although not all of these persons earned the right to receive benefits.

The value of Plan Assets, after subtracting Liabilities of the Plan, was \$450,417,550 as of October 31, 2022, compared to \$514,038,177 as of November 1, 2021. During the Plan Year, the Plan experienced a decrease in its Net Assets of \$63,620,627. This decrease included unrealized appreciation in the value of Plan Assets; that is, the difference between the value of the Plan's Assets at the end of the year and the value of the Assets at the beginning of the year or the cost of the Assets acquired during the year. The Plan had total income of \$-33,860,687, including (but not limited to) employer contributions of \$26,936,327, realized losses of \$316,542 from the sales of assets, earnings from investments of \$60,564,982 and other income of \$84,510.

5. Information regarding any common or collective trusts, pooled separate accounts, master trusts, or 103-12 investment entities in which the Plan participates.

If you request a copy of the full Annual Report from the Plan Administrative Manager, these two Statements and accompanying notes will be included as part of that Report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the Report because these portions are furnished without charge.
